Sealed Bids for the construction of the Prospect Street Water Main Replacement project will be received by the City of Crescent City, Florida at the office of the City Manager, City Hall, 3 North Summit Street, Crescent City, Florida 32112, until ~~February 20, 2024 at 2:00 p.m.~~ *February 27, 2024 at 11:00 a.m.* local time. At that time, the Bids received will be publicly opened and read aloud.

The Project includes the following Work: Constructing approximately 300 LF of 6" PVC water main; 7,400 LF of 8" PVC/FPVC water main; fire hydrants; connection to existing mains; and abandonment of existing water main in project area.

Bids are requested for the following Contract: Prospect Street Water Main Replacement, DEP Agreement No. LPA0500, SJRWMD Contract No. 38880.

Prospective Bidders may examine the Bidding Documents at the Issuing Office, Monday through Friday (excluding holidays), and may obtain copies of the Bidding Documents from the Issuing Office as described below.

Bidding Documents will be provided electronically as portable document format (PDF) files and as printed Bidding Documents, both for a non-refundable charge of \$150 per set payable to "Mittauer & Associates, Inc." Upon Issuing Office's receipt of payment, the digital files will be emailed, and the printed Bidding Documents will be sent via UPS Ground. Partial sets of Bidding Documents will not be available from the Issuing Office. Neither Owner nor Engineer will be responsible for full or partial sets of Bidding Documents, including addenda, if any, obtained from sources other than the Issuing Office.

Bidding Documents also may be examined at the office of the City Manager, 3 North Summit Street, Crescent City, Florida 32112, (386) 698-2525, Monday through Friday (excluding Holidays).

Bid security must be furnished in accordance with the Instructions to Bidders.

To be considered qualified, Bidder must be licensed to engage in the business of contracting in the State of Florida by the Construction Industry Licensing Board and must have successfully completed, as prime contractor, a minimum of 3 projects of a similar nature within the past 5 years, each having a minimum contract value of \$500,000 with at least one project having a contract value in excess of \$750,000.
