Sealed Bids for the construction of the Pump Station No. 2 Rehabilitation project will be received by the Town of Zolfo Springs, Florida at its Utility Office, 104 West Fifth Street, Zolfo Springs, Florida 33890, until March 18, 2025 at 11:00 a.m. local time. At that time, the Bids received will be publicly opened and read aloud at Town Hall, 3210 Main Street, Zolfo Springs, Florida 33890.

The Project includes the following Work: Furnishing all labor, materials, equipment, incidentals, and taxes to construct improvements at Pump Station No. 2 and furnish and install a trailer-mount diesel back-up pump system.

Bids are requested for the following Contract: Pump Station No. 2 Rehabilitation, State Agreement No. LPA0705.

Upon Issuing Office's receipt of payment, the digital files will be emailed, and the printed Bidding Documents will be sent via UPS Ground. Partial sets of Bidding Documents will not be available from the Issuing Office. Neither Owner nor Engineer will be responsible for full or partial sets of Bidding Documents, including addenda, if any, obtained from sources other than the Issuing Office.

Bid security must be furnished in accordance with the Instructions to Bidders.

To be considered qualified, Bidder must be licensed to engage in the business of contracting in the State of Florida by the Construction Industry Licensing Board and must have successfully completed, as prime contractor, a minimum of 3 projects of a similar nature within the past 5 years, each having a minimum contract value of \$300,000, with at least one project having a contract value in excess of \$500,000.
