Sealed Bids for the construction of the SCOP FY 22 Skelton Street Resurfacing project will be received at the office of the Town Clerk, 1580 Hwy 90 (P.O. Box 214), Ponce de Leon, Florida 32455, until 2:00 p.m. local time on October 13, 2022, at which time the Bids received will be publicly opened and read aloud.

The Project includes the following Work: Reworking approximately 4,700 SY of existing asphalt pavement and removal of approximately 250 CY to reconstruct the existing asphalt pavement section with shoulders requiring 7,800 SY of base materials and 875 TN of asphaltic pavement. Work also includes removal and replacement of driveways and asphalt turn outs with associated striping and restoration improvements.

Bids are requested for the following Contract: SCOP FY 22 Skelton Street Resurfacing, FDOT Financial ID No. 448039-1-54-01, FDOT Contract No. G1Z53.

Prospective Bidders may examine the Bidding Documents at the Issuing Office, Monday through Friday (excluding Holidays), and may obtain copies of the Bidding Documents from the Issuing Office as described below.

Bidding Documents will be provided electronically as portable document format (PDF) files and as printed Bidding Documents, both for a non-refundable charge of \$150 per set payable to "Mittauer & Associates, Inc." Upon Issuing Office's receipt of payment, the digital files will be emailed, and the printed Bidding Documents will be sent via UPS Ground. Partial sets of Bidding Documents will not be available from the Issuing Office. Neither Owner nor Engineer will be responsible for full or partial sets of Bidding Documents, including addenda, if any, obtained from sources other than the Issuing Office.

Bidding Documents also may be examined at the office of the Town Clerk, Town of Ponce de Leon, 1580 Hwy 90, Ponce de Leon, Florida 32455, (850) 836-4361, Monday through Friday (excluding Holidays).

Bid security must be furnished in accordance with the Instructions to Bidders.

To be considered qualified, Bidder must be licensed to engage in the business of contracting in the State of Florida by the Construction Industry Licensing Board and must have successfully completed, as prime contractor, a minimum of 3 projects of a similar nature within the past 5 years, each having a minimum contract value of \$250,000 with at least one project having a contract value in excess of \$500,000.

The Contractor must be prequalified with the Florida Department of Transportation (FDOT) pursuant to Section 337.14 F.S. and Chapter 14-22 FAC.
